

City Administrator & Staff Update

- Work Session Planning Efforts (and Samples), CIP Like to be thinking about an appropriate time for a works session. I have a couple update scopes of service to review and one other firm.
- **Beaverdale:** I have contacted Beaverdale with a request to review their status on infrastructure improvements, funding, etc. We will likely submit our letter of intent to pull out but continue to meet as well. Infrastructure needs repaired, costs (50%) over WB residents and doing their own repairs. Ideally their usage isn't counted against ours, or in theory, they could contract directly with Burlington. Much to discuss.
- **Pool:** See the attached sales summary noted last week, only updated.
- Mt. Pleasant: We met with the Contractor last week to go over potential solutions to the surface course on the West Burlington project. Norris recommended (per our suggestion) blowing out the pop outs and filling them with an epoxy than following up with a fog seal to help seal the coarse areas. They said they will follow IDOT's advice to refill the core hole locations. IDOT agreed that filling in the holes with an epoxy and then fog sealing the lane is a reasonable approach (along with redoing the core holes).
- Water Tower: We meet with the Boomerang Office Manager. They went through a number of factors dealing with their own internal issues over the past year or so that affected the project and timing. Hoping to see if we would concur with a reduction in liquidated damages, but nothing suggests that the dates should change based on what we heard this week. The tower wasn't filling to capacity just one of several issues. Pay apps, a change order for the liquidated damages, and then closeout will be forthcoming.
- Credentialing: My ICMA Credentialed Manager (ICMA-CM) status was approved following my annual submittal.
- **Library:** Attached is the revised Library report. Brittany said that, although many rural libraries are at risk of losing all of their budget, BPL is only at risk of losing part (a good portion) of its funding. Nevertheless, that will not change what West Burlington pays for library services. If you have any questions, please let me know. I will see you next week at the West Burlington City Council meeting. someone move the bees rather than kill them. They aren't bothering anything at present time but will be in future.
